

GENERAL GUIDELINES FOR COMPLETION OF THE AARTO 10 FORM

- Paper forms should be completed in black ink. Do **NOT** use pencil.
- Complete all required fields but special attention should be given to the "key fields" as listed below.
- Your application submitted cannot be entered into the NCR if the "key fields" are incomplete or incorrect.
- Please note that only the prescribed published AARTO 10 form should be utilized for submission. No affidavit/letter.
- The original infringer (proxy in the case of a juristic person) must sign the form.
- Please keep a copy of your application for your own records.
- This form may only be submitted in infringement notice status / courtesy letter status). (**NOT** in enforcement order status).
- Please note that a physical address and NOT a postal address should be furnished for service of a summons in terms of the Criminal Procedure Act, 1977 (Act No. 51 of 1977). Such summons will be prepared and served by the applicable Issuing Authority.
